- 1. Bidders must buy a bidding Document from the Procurement and Disposal Unit.
- 2. Payment of Non-Refundable Fees as Hereunder For the Bid Document.

- 3. Payment of non- refundable fees should be made in dfcu bank on Account Number 01983501004944 **Kiruhura DLG Collections account.** The Duplicate Pay in slip must be presented to the district cashier before securing the bidding documents.
- 4. Bidders must route their application through their area chairmen lc1 and sub-county chiefs failure of which shall lead to disqualification.
- 5. Attachments of photocopy of a national identity card is a must. Those applying as companies, associations or groups must attach Identity cards for the Chairperson and secretary.
- 8. Tender for collection of revenue from all sources will run for 6 months i.e. January 2026 to 30th June, 2026.
- 9. Bidders must attach passport size photograph. Those applying as companies, associations or groups must attach photographs for the Chairperson and secretary.
- 10. Those applying as companies, associations or groups must attach copies of their legal documents.

NOTE: Organized and registered groups for Livestock markets will be given priority.
